## Safeguarding:

Safeguarding children in our school is the responsibility of everyone. As such, all the staff in our school have a duty to safeguard and promote the welfare of children. This duty is placed upon the school by Section 175 of the Education Act 2002.

This means that we have a Designated Leader for Child Protection. In our school this is Mrs Burtoft, Mrs Peake and Mrs Gupta.

If we are concerned that a child may be at risk from significant harm school is required to refer their concerns onto the appropriate agency. In some circumstances this may happen without the consent or knowledge of parents/carers.

School also has a responsibility to act upon other concerns that they may have about a child's welfare in circumstances where there are no suspicions of child abuse. Examples of this may be when a child is demonstrating inappropriate behaviour, is involved in bullying, is failing to come to school or where difficulties at home are having an effect on the child's wellbeing.

In Lancashire there is an expectation that school will always discuss these issues with parents/carers before deciding upon a course of action to support the child and the family.

Our full safeguarding policy is available in school.

It is our view that safeguarding is not just about protecting children from deliberate harm. It also includes other issues, which are supported in many of our policies and procedures

- Internet safety
- School security
- Safe Recruitment

As the school gives the highest importance to the safeguarding and welfare of children and young people, the Governors, Headteacher and staff will carry out their responsibilities efficiently, effectively and diligently to ensure that this school is a safe learning environment.
